SHIPPENSBURG-- Red, white, and blue wave in the wind as Greiman city representatives hoist the American flag high into the air. Inside, themed garland and stars decorate the walls. At Girls’ State, pride in country represents a significant focus of the program.

Through a variety of activities, Girls’ State introduces citizens to both notable American ceremonies and the character of patriots. At daily flag ceremonies, girls observe the appropriate way to handle the American flag and crucial decorum, including when to place one’s hand over their heart.

“KGS only reinforces how proud I am of being an American” Greiman City Custodian of Records Anna Weinstein said.

Patriotism constitutes much more than just wearing the nation's colors, however. Patriotism constitutes individual commitment to bettering one's community; to appreciating service; and to serving others. Patriots strive not to boast their superiority, but instead to make their country the best it can be through kindness, advocacy, consideration, and determination.

At meals, citizens collaborate with their fellow hall residents to express pride in their cities through cheers. Beyond these external events, however, in city meetings and campaigns, to make their city the best possible, girls must engage in self-discovery and learn to identify and celebrate the accomplishments and unique abilities of their teammates.

Citizens additionally recall that their participation in this program results from the faith of American Legion posts and sponsors, who dedicated funds and support, through thank-you letters to their sponsors and performing their best every day.

# THE SISTER CITY TRIAL

The sister cities within Blue County, McKay and Seifert, generally participate in conjoint events whether that be through party meetings, or a exciting dance party. In other words, both cities interact with each other extremely well and they always find a way to participate in events while still competing for the top spot in earning honors city points. Today on June 19th, 2018, Blue County had the privilege of participating in our very first mock trial of the Keystone Girls State 2018 program year.

The city of McKay filed a lawsuit against Seifert City for the damages of Haley Miller. The plaintiff, Haley Miller, described her experience while entering Seifert City as “dangerous” and claimed that she was being taunted while being arrested. Miller was arrested due to her lack of cooperation to follow the Seifert City city ordinances. The city ordinance that is being referred too is the rule that when you enter their city, the outside citizen must maintain one hand on the wall - unless instructed by a city member to not do so. The plaintiff claimed that when she was arrested, she fell as a result of the improper treatment of the Seifert City state troopers (officers who conducted the arrest). Although the plaintiff was attempting to prove that the plaintiff obtained the damages (injury), the defense had extensive evidence to prove the injuries were indeed on her own accord.

The District Attorney, Madeline Wickel, represented the plaintiff during trial and utilized three witnesses, all of whom participate in different roles within their city - Haley Miller (Plaintiff), Gia Bugieda (Witness), and Abby Daniels (Expert Witness). These witnesses presented all information to the best of their ability when instructed to do so, and successfully answered the questions when asked during Direct or Cross Examination. The city Public Defender, Alexis Lukaszewski, defended her city against the accusations and also utilized three witnesses - Rachel Strode (Witness), Anai Walters (State Trooper witness), and Taylor Zimmerman (State Trooper Witness).

Both representatives have never participated in a mock trial, unlike our peers. Despite this seemingly intimidating obstacle, they were able to successfully debate the issue and learn how to properly participate in a trial. The trial maintained the ability to be continuously challenged and questioned, causing the trial to last the entire time originally allotted. Both councils were invested in the evidence being presented, and were always respectful of alternative opinions.

The ultimate end goal of the mock trial is not only to allow young women to participate in something closely related to a real court case, but to form new

relationships while doing so. As previously stated, both attorneys had never participated in anything related to the event, causing them to both learn so many lessons. Because of the Keystone Girls State program and the opportunities that are continuously available to all citizens will always allow us to reach for the stars, and to use our powers for good.
