Hrinya City Fills Four Red County Positions

County elections wrapped up on Monday, with each group of two cities electing three County Commissioners, a Treasurer, a Clerk, a Sheriff, and a District Attorney. All of these roles take on a larger constituency than city positions, and as such come with more responsibility. Four Hrinya City residents were elected into these exciting new positions in Red County.

Kelly Meirert, who won a County Commissioner seat, explains her motivations for pursuing this new position: "This was a good next step after becoming City Councilwoman. It will be a great opportunity to get more involved and take on more responsibility." As County Commissioner, Kelly will be responsible for county ordinances, actions needed to improve the county, and communication between the two cities. In order to effectively perform these tasks, Kelly has goals for her position. "I really want to get the two cities closer. After to day with all the arrests and stuff it was the first time we met each other. It was clear that we were already starting to get to know each other. I want us to get closer and work together as a county not just individual cities," she told the Keystone Gazette.

Another new County Commissioner from Hrinya is Melanie Sporn, who sees her position as a way to advocate for others. She explains: "I want to make sure that my city's voice is heard because we are smaller than some other cities. And even though we all have different personalities, I hope to use my voice to communicate for those who might be more shy." Melanie has loftier goals than some others, Lieutenant Governor to achieve this same goal on a larger scale. Overall, Melaine hopes to unify. She told the Gazette: "I want to unify the cities and make sure everyone feels comfortable with what is happening in their cities and make sure that everyone is able to come to me in case they have a concern."

Hrinya resident Lisa Bakhodirova was elected County Magistrate and will have responsibilities in presiding over court cases concerning the whole county. Lisa worked hard on her campaign, but not alone. She revealed: "I stayed up until 3AM to work on all my posters with my new friends." Lisa hopes to continue her hard working streak throughout her participation in government. "I plan to run for Supreme Court Justice because RBG inspired me to believe that anyone can change the world by assuming a higher position and using that influence," she relayed.

Finally, Ivy Snyder was elected County District Attorney. Her responsibilities include representing the Red County in county level trials. Ivy shared her enthusiasm for her new role, saying, "I will represent the Red County fairly and maintain justice in this great region." She explains her commitment by shedding light on her future goals: "I am passionate about the law and I want to get as much experience as possible to prepare for the future."

As county elections come to a close, the Keystone Girls State citizens begin to prepare for State elections, which will offer positions that carry even more responsibility.

Today at KGS, our state House was in session for the first time. The House began to discuss important bills on the floor, such as a fine for those who dispose of their trash in the Delaware River (presented by Peterson City), and a bill aimed at gun violence research and education (presented by Hrinya City). Before these bills were discussed, our state delegates elected a House Speaker and her Clerk. KGS's House Speaker is Mikayla Tillery from Peterson City. The Clerk is Maura Campbell, coming out strong for her city which is H. We had a wonderful House session, we were able to pass two bills this afternoon. After the session, I sat down with Tillery and Campbell to dive into their thoughts on the important roles that have taken on. They would like to share their thoughts with you also, as they are very happy and excited to be your Speaker and Clerk throughout the week. First, here is Tillery's response:

Mikayla Tillery: House Speaker-

Question: Why did you want to be speaker of the House?


Reinhard City Mayor and City Manager Arrested

Then began the process over again, this time only concerning the amendment to the bill. It was quickly realized time was getting close to being concluded, and a senator motioned to table the amendment and to rather finish the bill. The sponsor of the bill gave her summation speech and the Senate voted. The no votes were far more numerous compared to the yes votes and the bill, in the end, was failed. All senators then asked any remaining questions and after this, were dismissed.

Democratic Impingement Makes an Appearance in KGS County Elections

Hopeful eyes, now glazed over with expired patience, stood in unison outside of the voting room, awaiting their opportunity to participate in the rewarding realm of democracy. Anticipation existed in a tangible state, looming behind the casual conversations conducted by surrounding individuals as a means of passing the time. The preconceived notion of democratic perfection was firmly corroborated until the indiscriminate wielding of authoritative punishment initiated an ethical ripple effect, indelibly altering the political atmosphere of the White County.

Of these individuals vying for political distinguishment, Federalist June Park of Krumrine City appeared unparalleled in her efforts to achieve the coveted position of County Commissioner. While such an occurrence poses the threat of severe discouragement, Ms. Park took the opportunity to turn such an unfortunate experience into one of personal development, offering her testimony that, "My experiences of voter suppression opened my eyes to how dangerous voter suppression is. I simply ran to make it in time for voting but was arrested and ultimately my fundamental right to violate was violated. Fortunately, I had the support of my entire city watching me go through this traumatic experience and cheering me on and I am forever grateful".

Voter suppression stands as a burgeoning crisis, threatening the inalienable rights of individuals to fair and just democratic procedure. With this, the obligation of the individual is emphasized as societal demands call upon citizens, like Ms. Park, to combat the forces of democratic impingement to foster continuity in the global struggle for honest popular politics.
